As president and chief executive officer of the Greater Cleveland Partnership (GCP), one of the nation's largest metropolitan chambers of commerce, Joe Roman is helping to spur economic vitality in Northeast Ohio. Mr. Roman previously served as executive director of Cleveland Tomorrow, which merged with the Greater Cleveland Growth Association and the Greater Cleveland Roundtable to form the GCP.
